What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Affiliates	Companies related by common ownership and/or control. They ca be financial and nonfinancial companies.We do not share with our affiliates.	
Non-affiliates	 Companies not related by common ownership and/or control. The can be financial or nonfinancial companies. Non-affiliates include brokerage firms, investment advisory firms, attorneys, accountants, and other business professionals, as necessary. 	
Joint marketing	 A formal agreement between non-affiliated financial companies that together market financial products or service to you. We do not jointly market with affiliates. We do not jointly market with non-affiliates.
