



**FACTS** **WHAT DOES HIGHPOINT ADVISOR GROUP, LLC DO WITH YOUR FINANCIAL INFORMATION?**

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depends on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and assets
- Transaction history

**How?** All financial companies need to share customers’ personal information to perform their services and run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons HighPoint Advisor Group, LLC chooses to share; and whether you can limit this sharing.

<b>For our affiliates’ everyday business purposes—</b> information about your transactions and experiences	No	We don’t share
<b>For our non-affiliates’ everyday business purposes—</b> information about your transactions, accounts, etc., as necessary	No	We don’t share
<b>For our affiliates to market to you</b>	No	We don’t share
<b>For our non-affiliates to market to you</b>	No	We don’t share

<b>What we do</b>	
<b>How does HighPoint Advisor Group, LLC protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards (such as password protection or encryption) and restricting access to physical files (such as locked cabinets or building).
<b>How does HighPoint Advisor Group, LLC collect my personal information?</b>	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>• Open an account</li> <li>• Deposit money</li> <li>• Seek advice about your investments</li> <li>• Enter into an investment advisory contract</li> <li>• Provide us with information about your investment or retirement portfolio or earnings</li> </ul> We also collect your personal information from other companies.
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only: <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for non-affiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.
<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership and/or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>• We do not share with our affiliates.</li> </ul>
<b>Non-affiliates</b>	Companies not related by common ownership and/or control. They can be financial or nonfinancial companies. <ul style="list-style-type: none"> <li>• Non-affiliates include brokerage firms, investment advisory firms, attorneys, accountants, and other business professionals, as necessary.</li> </ul>
<b>Joint marketing</b>	A formal agreement between non-affiliated financial companies that together market financial products or service to you. <ul style="list-style-type: none"> <li>• We do not jointly market with affiliates.</li> <li>• We do not jointly market with non-affiliates.</li> </ul>
